Explanatory Note

This Amendment No. 8 (the “Amendment”) to Schedule 13D (as amended, this “Schedule”) amends certain items of the Schedule 13D originally filed on January 19, 2012 (the “Original 13D) filed by Kenneth B. Dart (the “Reporting Person”) and certain affiliates as amended from time-to -time. Capitalized terms not defined shall have the meanings set forth in the Original 13D.

Item 4. Purpose of Transaction.

Item 4 is hereby amended and supplemented as follows:

Pursuant to an Exchange Agreement dated February 23, 2017, an entity indirectly owned 100% by the Reporting Person (“the Affiliate”) acquired one (1) share of the Issuer’s Preferred Stock designated as iBio CMO Preferred Tracking Stock with a par value of \$0.001 per share (the “Preferred Tracking Stock”) in exchange for 29,990,000 units of limited liability company interests of iBio CMO LLC (“Units”) held by the Affiliate. iBio CMO LLC is a subsidiary of the Issuer. The shares of the Preferred Tracking Stock are exchangeable for Units only after March 31, 2018 (“Mandatory Exchange”), or an event which triggers a change of control of iBio CMO LLC, or in connection with a winding up, liquidation or deemed liquidation (such as a merger) of the Issuer or iBio CMO, subject to the terms and conditions set forth in the Exchange Agreement and the Certificate of Designation, Preferences and Rights of the iBio CMO Preferred Tracking Stock. The Preferred Tracking Stock is not convertible into or exchangeable for any securities of the Issuer.
