- Settlement of restricted stock units ("RSUs"). On December 21, 2012, the reporting person was granted 10,000 RSUs, vesting in two
- (1) installments as follows: 2,500 on June 30, 2013 and 7,500 on December 15, 2014. Each RSU represents a contingent right to receive one share of Allison Transmission Holdings, Inc. ("ALSN") common stock.
