This Amendment No. 3 amends the Schedule 13D filed September 7, 2007 (the "Schedule 13D"), as amended by Amendment No. 1 filed October 30, 2007, as amended by Amendment No. 2 filed November 6, 2007, and is filed by Bulldog Investors General Partnership (the "Reporting Person"), with respect to the common shares of beneficial interest, no par value, of PBF (the "Common Stock"). Capitalized terms used herein but not defined herein shall have the meanings attributed to them in the Schedule 13D.

**Item 1. Security and Issuer**

Item 1 of the Schedule 13D is amended and restated as follows:

The class of equity to which this statement relates is the common shares of beneficial interest, no par value (the "Common Stock"), of Pioneer Municipal and Equity Income Trust (formerly known as Pioneer Tax Advantaged Balanced Trust) ("PBF"), which has its principal offices at 60 State Street, Boston, MA 02109.
