(3) Restricted share units convert on a one-to-one basis into common stock on the vesting date.

(4) Total includes 18,950 shares of restricted stock held by the issuer to implement restrictions on transfer unless and until certain conditions are met and 7,960 restricted share units, which represent the right to received shares of common stock on a one-to-one basis upon vesting, which is generally three years from the date of grant, subject to terms and conditions. Prior awards of restricted stock units, which have different vesting provisions, have been reported in Table II.
