(1) The restricted stock units were acquired pursuant to the PDC Energy, Inc. Amended and Restated 2010 Long-Term Equity Compensation Plan and will vest in three equal annual installments beginning on February 20, 2020.

(2) 401(k) Plan holdings as of February 21, 2019.

Each performance share unit represents a contingent right to receive 0-200% of that number in shares of Company common stock. The amount reported represents the "target" number. The performance shares units vest upon continued employment and achievement of specified metrics compared to certain peers, as measured in December of 2021 and as described in the related grant agreement.
