Each Basket Component is a price index. The EURO STOXX 50 [®] Index will be given an initial weight of 40.00%, each of the FTSE [®] 100 Index and the Nikkei Stock Average Index will be given an initial weight of 20.00%, each of the Swiss Market Index and S&P/ASX 200 Index will be given an initial weight of 7.50% and the Hang Seng [®] Index will be given an initial weight of 5.00%
Automatic Call	The notes will be called automatically on any Observation Date if the closing level of the Market Measure is to or greater than the Call Level
Call Level	100% of the Starting Value
Observation Dates	Approximately one year and two years from the pricing date
Call Amount	[\$11.10 to \$11.20] if called on the first Observation Date and [\$12.20 to \$12.40] if called on the second Observation Date, each to be determined on the pricing date
Payout Profile at Maturity	If the Market Measure is flat or increases up to the Step Up Value, a return equal to the Step Up Payment If the Market Measure increases above the Step Up Value, a return equal to the percentage increase in the Market Measure 1-to-1 downside exposure to decreases in the Market Measure, with up to 100% of your principal at risk
Step Up Value	130% of the Starting Value
Step Up Payment	\$3.00 per unit, a 30% return over the principal amount
