The RSUs vest as follows and are settled in Zoetis common stock upon vesting: 4,349.3123 RSUs vested on March 4, 2017; 4,308.6685 RSUs will vest on September 2, 2017; 1,982.3760 RSUs will vest on February 27, 2018; 2,208.3627 RSUs will vest on February 19, 2019; 5,387.8779 RSUs will vest on August 22, 2019; 2,991.8093 RSUs will vest on December 6, 2019; and 8,481 RSUs will vest on February 14, 2020.
