Item 8.01. Other Events.

On December 31, 2014, Cliffs Natural Resources Inc. and its wholly-owned subsidiaries, Cliffs Logan County Coal LLC, Toney's Fork Land, LLC, Southern Eagle Land, LLC and Cliffs Logan County Coal Terminals LLC (collectively, the "Company"), completed the previously announced sale of its Logan County coal assets in southern West Virginia to Coronado Coal II, LLC for a purchase price of \$174 million in cash and the assumption of certain liabilities. The expected tax benefit associated with the transaction will be between 20% to 25% of the previously disclosed pre-tax loss of approximately \$400 million, which represents an additional benefit to the Company of \$80 million to \$100 million in future cash tax savings.
