BHP Billiton Limited announces that on 22 November 2007 it purchased 1,562,463 ordinary shares of BHP Billiton Plc at an average price of 1,485.29 pence per ordinary share.

Following the above transaction, BHP Billiton Plc holds 24,165,516 of its ordinary shares as treasury shares and BHP Billiton Limited holds 32,184,973 of the ordinary shares in BHP Billiton Plc, forming a total of 56,350,489 shares. The total number of BHP Billiton Plc ordinary shares in issue (excluding shares held as treasury shares and shares held by BHP Billiton Limited) is 2,224,808,573.
