- Performance share units (PSU) were granted to the reporting person pursuant to the Taubman Company 2008 Omnibus Long-Term Incentive Plan (Omnibus Incentive Plan). Each PSU represents a contingent right to receive, upon vesting, shares of the Company's common stock ranging from 0-300% of the PSU based on the Company's total shareholder return relative to that of a peer group. The PSU vested on March 1, 2013 with a payout ratio of 300%, which was certified by the Company's Compensation Committee on March 7, 2013.
- (1) common stock ranging from 0-300% of the PSU based on the Company's total shareholder return relative to that of a peer group. The PSU vested on March 1, 2013 with a payout ratio of 300%, which was certified by the Company's Compensation Committee on March 7, 2013.
