This Amendment No. 4 (this "Amendment") amends and supplements the statement on Schedule 13G (the "Schedule 13G") dated February 14, 2013, as subsequently amended by Amendment No. 1 dated February 13, 2014 ("Amendment No. 1"), Amendment No. 2 dated February 17, 2015 ("Amendment No. 2") and Amendment No. 3 dated April 9, 2018 ("Amendment No. 3"), filed jointly by Genextra S.p.A. ("Genextra") and Francesco Micheli, with respect to the shares of common stock, par value \$0.001 per share ("Common Stock"), of Intercept Pharmaceuticals, Inc. (the "Issuer"). Capitalized terms used in this Amendment without definition have the meanings ascribed to them in the Schedule 13G.

Items 4 and 5 of the Schedule 13G are hereby amended and supplemented to add the following:

Item 4. Ownership:

(a) Amount beneficially owned:

Genextra beneficially owns 6,095,578 shares of Common Stock.

Mr. Micheli beneficially owns 6,095,578 shares of Common Stock, consisting of 6,095,578 shares of Common Stock owned by Genextra. Mr. Micheli is an Executive Director and Chairman of the board of Genextra and, in such capacity, Mr. Micheli exercises voting control over the shares of Common Stock owned by Genextra. Mr. Micheli disclaims beneficial ownership with respect to any such shares, except to the extent of his pecuniary interest therein, if any.

The percentage of Common Stock beneficially owned by each Reporting Person as of February 8, 2019 is based on a total of 29,654,468 shares of Common Stock of the Issuer outstanding as of September 30, 2018, as disclosed in the Issuer's Form 10-Q dated November 1, 2018, filed with the Securities and Exchange Commission on November 1, 2018.
