Haifa, Israel, January 11, 2011 - Elbit Systems Ltd. (NASDAQ and TASE: ESLT) announced today that its subsidiary, Elisra Electronic Systems Ltd. ("Elisra"), was awarded a contract valued at approximately \$29 million to supply the Korean Government with Airborne Electronic Warfare (EW) Suites and Missile Warning Systems (MWS) for its ROKAF CN-235 Transporters. The advanced and integrative EW suites include protection systems against various threats.
