CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 25,977,420 shares or 9.6% of the 270,336,902 shares of Common Stock believed to be outstanding.
