CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 3,681,400 shares or 3.0% of the 122,382,000 shares of Common Shares believed to be outstanding.
