(350,000 shares); Jeanette Satterfield Kaiser (31,000 shares); Richard Kaiser (8,000 shares); and David Satterfield (5,000 shares). These individuals and entities have the right to receive or the power to direct the receipt of the proceeds from the sale of their respective shares.
