On June 29, 2006, the Reporting Person converted 394,986 shares of Class B Common Stock into an equal number of shares of Class A Common Stock.

- (2) Delivery of shares by Reporting Person to satisfy the remaining portion of a stock loan entered into prior to the Issuer's initial public offering.
  - (3) The Reporting Person has a short position of 500,000 shares of Class A Common Stock established prior to the Issuer's initial public offering.
  - (4) The Reporting Person disclaims beneficial ownership of these shares to the extent he does not have a pecuniary interest in such securities.
  - (5) There is no exercise or conversion price for the Class B Common Stock. It is convertible into shares of Class A Common Stock on a one-to-one basis.
- Shares of Class B Common Stock may be converted immediately on a one-for-one basis by the holder and are automatically converted into Class A Common Stock on a one-for-one basis upon transfer to a person or entity that is not a "Permitted Transferee" or soon after a record date for a meeting of stockholders where the outstanding Class B Common Stock constitutes less than 10% of the outstanding shares of Common Stock of the Issuer.
