- (2) Jay C. Hoag ("Hoag") and his wife are the sole trustees of The Hoag Family Trust U/A Dtd 8/2/94. Hoag disclaims beneficial ownership of such shares except to the extent of his pecuniary interest therein.
- (3) Hoag acquired 12,500 shares and surrendered back to the Issuer 8,552 shares at \$32.93 per share, for a net exercise of 3,948 shares.
Hoag has the sole voting and dispositive power over the shares he holds directly, however, TCMI, Inc. holds 100% of the pecuniary
