- (1) On January 2, 2008, the Issuer entered into an agreement with Thomas D. Myers (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 12,000 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 70,700 restricted shares of Class A Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan. On March 12, 2007 and January 2, 2008, restrictions applicable to previous grants of 2,500 restricted shares and 5,000 restricted shares, respectively, of each of Class A Common Stock and Common Stock lapsed resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
