- (1) Until June 25, 2012, Blackstar InvestCo LLC ("Blackstar") had been 60% owned by Daimler North America Corporation and 40% owned by Aabar Blackstar Holdings GmbH ("Aabar"). On June 25, 2012, in connection with the redemption by Blackstar of all of Aabar's membership interest in Blackstar, Blackstar transferred 3,245,286 shares (Aabar's pre-redemption proportional indirect interest in the shares held by Blackstar) to Aabar. No additional consideration was provided.
- (2) The shares are directly owned by Blackstar. The reporting person is a vice president of Blackstar and disclaims beneficial ownership of these shares, except to the extent of his pecuniary interest therein. This report shall not be deemed an admission that the reporting person is the beneficial owner of such securities for Section 16 or any other purpose.
