- (1) On December 8, 2009, the Company granted 1,500 restricted shares under the Company's Management Long Term Incentive Program. The stock was subject to a repurchase option in favor of the Issuer and to restrictions on transfer until it vested in accordance with the provisions of the Restricted Stock Purchase Agreement on December 8, 2013. 773 of the 1,500 shares that vested December 8, 2013 were withheld to cover withholding taxes due upon vesting.
