**Item 8.01. Other Events**

On October 22, 2014, Mercury General Corporation, a California corporation (the “Company”), entered into a Stock Purchase Agreement (the “Purchase Agreement”) with C&D Shammass Realty, LP, a California limited partnership, Workmen’s Holding Company, a California corporation, and Workmen’s Auto Insurance Company, a California domestic property and casualty insurance company (“Workmen’s”). Pursuant to the terms of the Purchase Agreement, the Company has agreed to acquire all of the issued and outstanding capital stock of Workmen’s for an aggregate purchase price of \$8 million.

The transaction is subject to customary closing conditions, including, among others, (i) receipt of regulatory and other approvals, consents and permits required to complete the transaction; (ii) absence of any order or injunction prohibiting the consummation of the transaction and (iii) absence of a material adverse effect on the Company prior to the closing.

A press release, issued October 23, 2014, announcing the Purchase Agreement, is attached as Exhibit 99.1 hereto and is incorporated herein by reference.
