Santiago, Chile. September 17, 2015.- Sociedad Química y Minera de Chile S.A. (SQM or the “Company”) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) announced today that the earthquake that occurred yesterday in central Chile did not damage our production facilities, which continue to operate normally. There were no accidents or injuries involving our workers that live in the areas affected by the earthquake; however, SQM is providing support to those workers who require it.
