(iv) 1,021,904 shares of Common Stock directly owned by certain accounts (the "Managed Accounts") managed or advised by York Managed Holdings, LLC ("York Managed Holdings") or York UCITS Holdings, LLC ("York UCITS Holdings").

YGA, the sole managing member of the general partner of each of York Select, York Select Master and York Select Investors and the sole managing member of York Managed Holdings and York UCITS Holdings, exercises investment discretion over such investment funds and the Managed Accounts and accordingly may be deemed to have beneficial ownership over the shares of Common Stock directly owned by such investment funds and the Managed Accounts.
