- (1) As adjusted to reflect the effect of a 5% stock dividend which became effective June 29, 2007. As a result of the stock dividend, the reporting person received an aggregate of 208 additional shares which are included in the common stock shares reported as held directly. At the same time, and in accordance with antidilution provisions of the Issuer's Director Stock Option Plan, the reporting person's stock options became exercisable for 328 additional shares, and the exercise price was similarly adjusted.
- (2) Due to a reporting error, the beneficial ownership previously reported for this reporting person reflected 8 shares more than was actually owned. The correct amount of common stock, after the stock split should be 4,360 shares as indicated in column 5 of this report.
