Item 1.01 Entry into a Material Definitive Agreement.

On April 14, 2009, Sunoco Logistics Partners L.P., (the Partnership) and its wholly-owned subsidiary, Sunoco Logistics Partners Operations L.P. (the Operating Partnership), entered into an underwriting agreement (the Underwriting Agreement) with Citigroup Global Markets Inc., Barclays Capital Inc. and UBS Securities LLC, as representatives of the underwriters (the Underwriters) with respect to the issue and sale by the Partnership of up to 2,530,000 common units (which includes an option to purchase up to 330,000 additional common units to cover over-allotments) representing limited partner interests in the Partnership (the Units), in an underwritten public offering (the Offering). The Underwriters are offering the Units at an initial offering price to the public of \$50.60 per Unit. The Units to be issued pursuant to the Underwriting Agreement were registered under the Securities Act of 1933, as amended pursuant to an effective shelf registration statement on Form S-3 (File No. 133-155644). A copy of the Underwriting Agreement is filed as Exhibit 1.1 to this report and is incorporated by reference herein.

The closing of the Offering is expected to occur on April 17, 2009.

In addition, the Partnership issued a press release on April 14, 2009 announcing the pricing of the Units. A copy of the press release is attached hereto as Exhibit 99.1.
