**On June 20, 2011, Constellation Energy sent the following communication to Baltimore Gas and Electric Company (BGE) employees regarding the merger integration process.**

*The following message is being sent to BGE, ComEd and PECO employees on behalf of Ken DeFontes, Frank Clark and Denis O Brien*

Two weeks ago, as you know, a team of leaders from across the Exelon and Constellation businesses met in Baltimore to officially kick off the integration planning process for our proposed merger under the leadership of **Ron DeGregorio** from Exelon and **Steve Woerner** from Constellation.

Teams have been formed to address integration as it relates to every facet of our companies. With regard to our utility businesses, we have recently engaged a team of leaders to focus on merger activities for BGE, ComEd and PECO. **Charlie White** will serve as the Exelon lead for the Utilities Business Area Team, with **John Borkoski** as his counterpart for Constellation. Also, **Kelly Colarelli** from PECO and **Ken Dorsey** from BGE will provide project support.

The Utilities Business Area Team includes five sub-teams. Below is a list of the employees we've asked to lead them:
