This Amendment No. 6 amends the Schedule 13D with respect to the Common Stock of Hallador Energy Company, a Colorado corporation formerly known as Hallador Petroleum Company (the Company), previously filed by Yorktown Energy Partners VI, L.P., a Delaware limited partnership (Yorktown), with the SEC on December 30, 2005, as amended by Amendment No. 1 filed with the SEC on May 24, 2011, Amendment No. 2 filed with the SEC on August 22, 2011, Amendment No. 3 filed with the SEC on November 18, 2011, Amendment No. 4 filed with the SEC on September 6, 2012 and Amendment No. 5 filed with the SEC on February 14, 2013 (the Schedule 13D). Capitalized terms used herein without definition shall have the meanings given to such terms in the Schedule 13D.

**Item 5. Interest in Securities of the Issuer.**

Subparagraphs a and c of Item 5 in the Schedule 13D are amended and restated in their entirety by the following:

(a) As of March 11, 2013, Yorktown, the General Partner and the LLC beneficially owned 1,650,637 shares of Common Stock of the Company, representing 5.8% of the issued and outstanding shares of Common Stock of the Company. All calculations made herein are made in accordance with Rule 13d-3(d) of the Securities Exchange Act of 1934, as amended, and based on 28,528,756 shares of the Common Stock of the Company issued and outstanding as of February 15, 2013, as set forth in the Company's information statement on Schedule 14C, filed with the SEC on March 8, 2013.

(c) On March 5, 2013, Yorktown distributed in-kind, on a pro rata basis and for no additional consideration, in accordance with its limited partnership agreement, an aggregate of 750,000 shares of Common Stock of the Company, to its limited and general partners (the Distribution). Upon the consummation of the Distribution by Yorktown, the General Partner distributed in-kind, on a pro rata basis and for no additional consideration, in accordance with its limited partnership agreement, all 158,867 shares of Common Stock of the Company received in the Distribution to its limited and general partners (the Subsequent Distribution). Upon the consummation of the Subsequent Distribution by the General Partner, the LLC distributed in-kind, on a pro rata basis and for no additional consideration, in accordance with its operating agreement, all 821 shares of Common Stock of the Company received in the Subsequent Distribution to its members.
