Included in the announcement was the advice that the currency conversion for Australian cents, British pence and New Zealand cents would be based on the foreign currency exchange rates on the Record Date, 5 September 2014, and for South African cents the Last Day to Trade on the JSE Limited, which was 29 August 2014<sup>2</sup>.
