This Amendment No. 2 to the Schedule 13G filed with the Securities and Exchange Commission on February 13, 2013 (as amended by Amendment No. 1 thereto filed on February 12, 2014, the **Schedule 13G**) is being filed on behalf of BlueMountain Capital Management, LLC ( **BMCM** ) and BlueMountain GP Holdings, LLC ( **GP Holdings** ) and together with BMCM, the **Reporting Persons** ) with respect to the shares of Common Stock, par value \$0.0001 per share (the **Common Stock** ) of Chart Acquisition Corp., a Delaware corporation (the **Issuer** ).
