- (1) Each restricted stock unit represents a right to receive one share of ESCA common stock granted pursuant to the Escalade, Incorporated 2007 Incentive Plan. This restricted stock unit grant is in lieu of cash compensation earned for services performed as a Director.
 - (2) Each restricted stock unit is vested upon grant and will be settled by the issuance of common stock on the deferral date elected by the recipient. The recipient has elected to receive the corresponding shares at the end of the calendar year five years from the date of grant.
 - (3) Outstanding restricted stock units are composed of 1,250 units that will vest and be settled on April 27, 2009; 2,288 units that are vested and will be settled on December 31, 2012; and 2,168 that are vested and will be settled on December 31, 2013.
 - (4) Outstanding stock options are composed of 2,000 options that vested on April 24, 2007 with an exercise price of \$11.26 per share and an expiration date of April 24, 2011; and 1,198 options that vested on April 30, 2008 with an exercise price of \$9.35 per share and an expiration date of April 30, 2012.
