 Mr. Penske also reports indirect beneficial ownership of 64,550 shares held by International Motor Cars Group II, LLC, 22,308,042 shares held by Penske Automotive Holdings, Inc., 13,311,817 shares held by PCP Holdings, Inc., and direct beneficial ownership of 707,081 shares. Mr. Penske disclaims beneficial ownership of all indirectly held securities, except to the extent of his pecuniary interest, if any, and this report shall not be deemed an admission that he is the beneficial owner of such securities for purposes of Section 16 or otherwise.
