- (1) This option was granted on March 11, 2004 and was repriced from \$14.90 to \$16.46 on December 28, 2005.

The remainder vests upon the reporting person's completion of each additional month of service, in a series of thirty-six (36) successive, equal monthly installments beginning with the first anniversary of the Vesting Commencement Date.
