The shares of common stock, including restricted stock, were cancelled pursuant to the Agreement and Plan of Merger with Buccaneer

(1) Holdings, Inc. and Buccaneer Merger Sub, Inc., dated as of October 28, 2010 (the "Merger Agreement"), in exchange for a cash payment in the amount of \$31.00 per share.

(2) The options, whether vested or unvested, were cancelled pursuant to the Merger Agreement in exchange for a cash payment in the amount of \$31.00 per share less the exercise price of the option.

(3) The options vest in three equal annual installments on each of January 14, 2009, January 14, 2010 and January 14, 2011.

(4) The options vest in three equal annual installments on each of January 14, 2010, January 14, 2011 and January 14, 2012.

(5) The options vest in three equal annual installments on each of August 10, 2010, August 10, 2011 and August 10, 2012.

(6) The options vest in three equal annual installments on each of February 17, 2011, February 17, 2012 and February 17, 2013.

(7) The options vest in three equal annual installments on each of August 5, 2011, August 5, 2012 and August 5, 2013.
