Settlement of Common Stock Equivalent Units awarded on March 25, 2008 under the Company's Performance Recognition Plan and 2005 Performance Plan, the payment of which had been deferred by the reporting person until after December 31, 2010. A total of 12,383 (1) shares of common stock were issued of which 4,938 shares were withheld for payment of taxes. The units had a value at January 20, 2011 (the date of distribution) equal to \$11.72 per unit, the fair market value of a share of common stock on that date (the average of the high and low per share sale prices as reported on the New York Stock Exchange Composite Transactions tape).
