(1) The transaction was effected pursuant to a Rule 10b5-1 plan dated February 27, 2014, and modified on August 12, 2014. The transaction was executed in multiple trades at prices ranging from \$2.5600 to \$2.7100. The price reported is the weighted average sale price for the number of shares sold. Full information regarding the number of shares sold at each separate price will be supplied upon request by the Securities & Exchange Commission staff, the Issuer or a security holder of the Issuer.

(2) This filing corrects an error made in a previous Form 4 filed by the Reporting Person on September 15, 2014 (the "Prior Filing"). The Prior Filing incorrectly reported 81,967 shares in Columns 5 and 6 of Table I as directly held by the Reporting Person when they should have been reported as indirectly held by trust.
