- (1) Shares issued upon settlement of vested restricted stock units ("RSUs").

The service-based vesting condition provides that 25% of the total number of shares on March 17, 2015 and 1/48th of the total number of shares monthly thereafter, subject to the holder's continuous service through each such date.
