- (1) (i) certain purchase price and other adjustments under Section 1.7 of the Merger Agreement, and (ii) resolution of certain other claims between the Issuer and BFTW LLC.
  - (2) Peter A. Bordes is a co-trustee of the Peter A. Bordes, Jr. 2009 Gift Trust. Mr. Bordes disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein, and this report shall not be construed as an admission that he is the beneficial owner

of such securities for any purpose.
