- On September 16, 2013, pursuant to an underwriting agreement dated September 11, 2013, among Neonode Inc. (the "Company"), the selling shareholders named therein (including Mr. Eriksson and Wirelesstoys Sweden AB, an entity beneficially owned by Mr. Eriksson), (1) and Craig-Hallum Capital Group LLC as underwriter (the "Underwriter"), Mr. Eriksson and Wirelesstoys Sweden AB sold an aggregate of 476,608 outstanding shares of common stock in the Company (including 150,000 shares through full exercise of the Underwriter's over-allotment option granted by Wirelesstoys Sweden AB) to the Underwriter at a price per share of \$6.60.
