(1) Grant to reporting person of restricted share units ("RSUs") pursuant to the 2012 Stock Incentive and Award Plan. RSUs vest one year after the grant date. When receipt is deferred under the Directors Deferred Compensation Sub-Plan, RSUs convert to an equal number of share equivalent units on the vesting date. When receipt is not deferred, RSUs convert to unrestricted Nordson Common Shares on a one-for-one basis on the vesting date.

(2) Share equivalent units accrued through Nordson's Directors' Deferred Compensation Plan. At time of distribution, share equivalent units convert to common shares on a one-for-one basis. Distribution is not permissible until participant ceases to be a director.
