- (1) Exempt grant of restricted stock units issued to the reporting person under the issuer's 2005 Incentive Compensation Plan in exchange for the reporting person's 2007 election to forego his annual retainer for service on the issuer's Board of Directors, computed on the basis of the closing price of the issuer's common stock on May 22, 2007. Each restricted stock unit represents a contingent right to receive one share of the Issuer's common stock.
