This grant was for 85,022 performance-vesting restricted stock units, each representing the right to receive one share of the Company's common stock. The number assumes maximum performance; target performance would result in a release of 42,511 shares of the

(1) Company's common stock. These performance-vesting restricted share units vest in accordance with Mr. Johnson's employment agreement with the Company, dated as of May 10, 2017 and effective as of June 26, 2017, and filed as an exhibit to the Form 8-K filed by the Company on May 11, 2017.
