Board of Directors.
 - (6) Includes acquisitions of 1,652.730, 1,573.024, 1,327.999 and 1,629.817 phantom stock units acquired through deemed dividend reinvestment on March 7, 2017, June 6, 2017, September 6, 2017 and December 5, 2017, respectively.
