- (1) Represents the weighted average purchase price for multiple transactions at prices ranging from \$7.04 to \$7.25 per share. - (2) Includes 8,000 shares of restricted common stock granted in November 2007 and 8,000 shares of restricted common stock granted in December 2008. 25% of the restricted common stock granted in November 2007 have vested and 25% will vest on November 30 of each of 2009, 2010 and 2011. The December 2008 grant is subject to time vesting and performance vesting. For time vesting, 25% vests on the third day following the issuance of the issuer's press release reporting first quarter financial results in February of each of 2010, 2011, 2012 and 2013, but no later than the end of February in each year. Performance vesting occurs upon the achievement of specified 20-trading-day average closing share price thresholds by the issuer's common stock: 50% of the restricted stock granted is subject to a \$13.50 average closing share price threshold and 50% is subject to a \$16.00 average closing share price threshold.
- (3) Represents the weighted average purchase price for multiple transactions at prices ranging from \$6.83 to \$7.42 per share. The undersigned undertakes to provide, upon request by the staff of the Securities and Exchange Commission, the issuer or a security holder
