ITEM 1. SECURITY AND ISSUER.

This Schedule 13D (this "Schedule") relates to the shares of common stock (the "Common Stock"), of Trio Tech International, a California corporation (the "Company"). The principal executive offices of the Company are located at 16139 Wyandotte Street, Van Nuys, California 91406.

ITEM 2. IDENTITY AND BACKGROUND.

This Schedule is being filed on behalf of Richard M. Horowitz, whose business address is 9301 Wilshire Blvd. Suite 613, Beverly Hills, California 90210. Mr. Horowitz is a director of the Company. Mr. Horowitz's principal occupation is as President of Management Brokers Insurance Agency, the principal business address of which is 9301 Wilshire Blvd. Suite 613, Beverly Hills, CA 90210. He also serves as Chairman of Dial 800, Inc., a national telecommunications company, the principal business address of which is 9911 West Pico Blvd., Suite 1200, Los Angeles, CA 90035. During the last five years, Mr. Horowitz has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors). During the last five years, Mr. Horowitz was not a party to a civil proceeding of a judicial or administrative body of competent jurisdiction. Mr. Horowitz is a citizen of the United States of America.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

Of the 346,705 shares deemed beneficially owned by Mr. Horowitz, 35,000 are subject to currently exercisable options. Mr. Horowitz acquired the remaining shares deemed to be beneficially held by him through the use of personal funds.

ITEM 4. PURPOSE OF TRANSACTION.

Mr. Horowitz holds the shares of Company Common Stock beneficially owned and deemed to be beneficially owned by him for investment. This Schedule is being filed to reflect Mr. Horowitz's holdings in light of a recent SEC Compliance and Disclosure Interpretation. Mr. Horowitz may acquire (either in the open market or pursuant to the exercise of options held by him) and/or sell shares of Common Stock from time to time as he deems advisable and depending on market conditions but has no present intention to do so. Except as set forth above, Mr. Horowitz does not have any present plans or intentions which would result in or relate to any of the matters set forth in subparagraphs (b) through (j) of the instructions to Item 4 of Schedule 13D.

ITEM 5. INTEREST IN SECURITIES OF THE COMPANY.

(a) As of April 15, 2010, based upon information provided by the Company, there were 3,227,430 shares of Common Stock outstanding. Mr. Horowitz is deemed to beneficially own 346,705 shares of Common Stock, or 10.6% thereof. Of those shares, 35,000 are issuable upon the exercise of currently exercisable option.

(b) Mr. Horowitz has both sole voting and sole dispositive power over all 346,705 shares of Common Stock deemed to be beneficially owned by him.

(c) During the past 60 days, Mr. Horowitz acquired on the open market the following shares of the Common Stock of the Company on the dates and for the price per share indicated below:
