- (1) Options become exercisable as to 25% on 4/28/09 and 1/48th monthly thereafter.
- (2) On September 11, 2009, the issuer canceled, pursuant to the issuer's option exchange program, an option granted to the reporting person on May 9, 2008. In exchange for the option, the reporting person received 12,500 restricted stock units. See also footnotes 4 and 7.
- (3) Each restricted stock unit represents a contingent right to receive one share of eBay's common stock.  
Upon surrender of the option reference in footnote 3, the reporting person received 12,500 restricted stock units subject to a four-year vesting schedule, vesting 25% on 9/11/10 and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

- (5) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/09 and 1/48th per month thereafter.
