On March 1, 2017, Eagle Bulk Shipping Inc. (the "Issuer") granted to Gary Vogel, a member of the Issuer's Board of Directors and the Issuer's Chief Executive Officer, 237,500 shares of restricted common stock. The shares of restricted common stock vest in three substantially equal installments on each of the following dates: (i) March 1, 2018, (ii) March 1, 2019 and (iii) March 1, 2020, subject to Mr. Vogel's continued employment with the Issuer or its affiliate on the applicable vesting date. In the event that Mr. Vogel's employment is terminated by the Issuer without cause or by him for good reason, his restricted shares will vest as if he remained employed with the Issuer for an additional year beyond the date of such termination as detailed in the Restricted Stock Award Agreement, dated March 1, 2017, by and between the Issuer and Mr. Vogel (the "RSA"). The shares of restricted common stock issued to Mr. Vogel described above were granted pursuant to the Eagle Bulk Shipping Inc. 2016 Equity Incentive Plan and the RSA.
