In the aggregate, First Trust Portfolios L.P., First Trust Advisors L.P. and The Charger Corporation held less than one percent of the common stock of Integrys Energy Group Inc. on December 31, 2008. In addition, the CUSIP Number, as originally filed, related to the preferred stock of Wisconsin Public Service Corporation (CUSIP Number 976843805). No Schedule 13G is required to be filed with respect to ownership of preferred stock, and, in fact, on December 31, 2008 no preferred stock of Wisconsin Public Service Corporation was held by First Trust Portfolios L.P., First Trust Advisors L.P. or The Charger Corporation.
