Hatsopoulos, and Nia Marie Hatsopoulos, for which Dr. George N. Hatsopoulos and Ms. Patricia L. Hatsopoulos are the trustees; and 28,225 shares of Common Stock held by Patricia L. Hatsopoulos.

Hatsopoulos disclaims beneficial ownership of the shares held by this trust.
