Company's Rights Agreement which entitles holders of the Company's Common Stock in the event certain specified events occur to acquire 1/100th of a share of Series A Participating Preferred

Stock at a price of \$145 per fractional share.

- (2) Right to buy pursuant to the Company's 1989 Stock Option Plan for Employees.
- (3) Shares held for my benefit as of February 28, 2003 under the Humana Retirement and Savings Plan ("HRSP") and a routine disposition of shares to fund an administrative fee assessment

under a Tax-Conditioned Plan, exempt under Rule 16b-3 (c).

- (4) Right to buy pursuant to the Company's 1996 Stock Incentive
- (5) Phantom Stock Units held for my benefit as of February 28, 2003 under the Humana Excess Plan exempt under Rule 16b-3(d).
