(1) Restricted stock award granted to reporting person under the Issuer's 2009 Omnibus Incentive Plan. The award will vest in full three years from the grant date on August 21, 2013.

(2) Represents shares issued upon payout of the Performance Share Awards granted on August 16, 2008 under the 2005 Omnibus Incentive Plan, the payout of which was contingent on the achievement of certain consolidated revenue and consolidated net cash provided by operating activities performance criteria. Pursuant to the awards, actual payouts were at 36.8% of the revenue target and 100.1% of the cash provided by operating activities target.

(3) The option vests in 5 equal annual installments beginning on August 21, 2011.
